We, as the national, provincial and territorial associations representing the museum community across Canada, are writing this open letter to you, with the federal election now underway, to urge your party to commit to prioritizing support for museums, large and small, across the country.

In our news release and flyer, attached, we highlight the urgent need for:

- A review and modernization of the National Museum Policy
- A review of funding streams for museums and an expansion of the Museums Assistance Program to ensure more sustainable funding
- A simplification of the funding process, especially for small museums

We note that in your platform you have committed to reviewing the National Museum Policy and to creating a \$200 cultural pass. However, we respectfully ask that during the election period you respond to the following questions:

1. What are your views on the importance and role of museums?
2. How would you respond to the other key recommendations above?

There are more than 19,000 employees and 65,000 volunteers working in this sector, in ridings across Canada. We are encouraging our members to ask candidates in their ridings about their commitment to the museum and heritage sector and, of course, to get out and vote.

We look forward to your response to our questions, which we intend to publish on our websites.
